# Achievements in 2025.

- ▶ Added an **additional 1,250 trees** to our forest for our customers.
- ▶ Retained our status as **Carbon Negative** company
- ▶ Continued with our **Ecosystem of 5 bee-hives** which are managed by Lisa McKenzie and David McDowell.
- ▶ Donated via our customers Derbyshire Children's Holiday Centre tree purchase option **£2,285 (£4,830** in total since the project's inception).
- ▶ Further developed the joint ally partnership with **The Uganda Environmental Conservationists Organization (UECO)**; planting **373** trees (including banana and fruit), visiting several schools and meeting **715** people. Also **5 bee hives** were set up and the **UECO demonstration farm**.
- ▶ Created an educational programme in Africa with Tricia Jewitt called **Design Environment 40LLC** where we will deliver the programmes using our partnership with **The Uganda Environmental Conservationists Organization (UECO)**.
- ▶ Held planting sessions with **BOAL UK Ltd, Choice Associates, Cosmetic Smiles, Cosy Direct, DNS, Environmental Agency and Gravity Digital** teams.
- ▶ With **7,750 trees** now planted the forest has absorbed an estimated **193,750 kg of CO<sub>2</sub>** from the atmosphere in 2025.

# Co-Treetment vision and highlights

- ▶ **We plant trees; and we do that in the UK only.**
- ▶ We maintain and guarantee our trees over their lifetime of 20 years.
- ▶ We are a not for profit (NFP) company.
- ▶ We don't take any salaries or dividends.
- ▶ We aim to bring clear, concise language and products that help in the understanding of how it is possible to make a positive impact on the planet.
- ▶ We want to leave a positive legacy that will help further generations.
- ▶ We are a **Carbon Negative** company across our scope 1, 2 and 3 emissions.

# Co-Treetment are Carbon Negative

- ▶ **Key facts for developing emissions profile**
- ▶ Co-Treetment is run and owned by 3 people; Simon Evans; Darrell Taylor and Keith Cox
- ▶ We only operate in the UK
- ▶ We have no buildings or offices
- ▶ We have no employees
- ▶ We have no company cars
- ▶ We all live approximately 25 miles from the field where we plant trees
- ▶ We administrate the business from home and on average spend 3 days per month each making sure the business runs smoothly
  - ▶ That's 1 day homeworking and 2 days field working
- ▶ We have **planted 250 trees** making us a **carbon negative company** which we achieved in 2023.
  - ▶ Exceeding 146 trees required to be **carbon neutral**

## Carbon Neutral

This is achieved when an organisation has measured its carbon footprint (CO<sub>2</sub>e) and then carries out carbon offsetting activities to try to remove the same amount of CO<sub>2</sub>e from the atmosphere.

This is when a company chooses to offset more carbon than they produce.



# Who are Co-Treetment?

Co-Treetment was formed in 2019 by Darrell Taylor, with the support of colleague and mentor Simon Evans and local business owner Keith Cox.

We noticed that companies tend to focus on their main products offerings and more often than not these businesses are unable to investigate optimum sustainability solutions.

This is the space where Co-Treetment's knowledge around the planting of trees and carbon off-setting come into play.

We set-up Co-Treetment to provide a consultative tree-planting service to local businesses in the East Midlands.

## What do we do?

Our core business is in planting trees; however, that's the tip of the iceberg.

Co-Treatment own land where we are developing our own small woodland, which will absorb water to reduce the risks of flooding, provide habitat for nature, and absorb Carbon from the atmosphere long into the future.

In addition, we are re-wilding areas of our land for bees and insects to thrive, creating homes for birds and other animals, planting memorial trees and creating a beautiful environment for future generations to enjoy.



# What makes us special?

We focus on improving our region, planting 100% of our trees right here in the East-Midlands, after-all if you produce emissions here then it makes sense to absorb them here too!



Our trees are all native to the UK and fit within our biosphere, they are guaranteed for a minimum of 20-years to honour the Carbon absorption that we commit to, and we over-plant to ensure there is always a little extra being absorbed too!

We are working with local charities, schools and organisations to share our initiative and expand the reach of the good work that we do, striving to make an impact ourselves while inspiring the next generations too.
